Training Program Requirements

1. Attend 14 weeks of training classes
 - Thursday evenings 6:30-9:30 pm
 - January - April 2025
 - 8600 Dixon Powers Dr. (Henrico Coop. Ext.)
2. Complete at least 10 hours of field training
 - Mostly on Saturdays
3. Complete training assessments

Complete Certification as a VMN Volunteer

1. Complete all basic training requirements within one year (preferably by the end of April).
2. Volunteer a minimum of 40 hours each year on Riverine approved projects.
3. Complete 8 hours of continuing education each year.
4. Pay \$25 membership fee

Some Considerations in Deciding Whether to Apply for the Program

- Do you have the time to attend all training classes & do 1-2 hrs of weekly homework?
- Can you attend field trips, which are usually on Saturdays? (you'll need several, and most people want to attend more)
- Do you have Internet to access class materials & use Zoom if weather cancels an in-person class?
